Your e-tender for the work mentioned above has been accepted by Chief Executive Officer, Puducherry Smart City Development Limited at your tendered amount of ₹89,99,794/- (Rupees eighty nine lakhs ninety nine thousand seven hundred ninety four only) which is -0.422% below to the estimate cost put to tender of ₹90,37,890/- (Rupees ninety lakhs thirty seven thousand eight hundred and ninety only).

You are requested to remit 3% of tendered value as Performance Guarantee for $\[\] 2,69,994/$ -(Rupees two lakhs sixty nine thousand nine hundred and ninety four only) and also to submit 2% of tendered value as Security Deposit for $\[\] 1,79,996/$ -(Rupees one lakhs seventy nine thousand nine hundred and ninety six only) specified in schedule E - Sl. No. II & III of NIT respectively, within 15 days from the date of this letter. The performance guarantee shall be in the prescribed form as provided in NIT and shall be valid **up to August 2022**.

The proposed site falls under CRZ-I B and CRZ-II as per the existing Coastal Zone Management Plan (CZMP) prepared under Coastal Regulation Zone (CRZ) notification, 2011. The Puducherry Coastal Zone Management Authority instructed strict compliances of the following condition during execution of the project.

- I. Bituminous road to be laid shall be restricted to CRZ-II area only and there shall be no laying of road in CRZ-I B area.
- II. There shall be no extension of road length and width wise other than those permitted by the PCZMA.

The absurdly low quoted rate items shall be executed fully and shall not alter under any conditions.

On receipt of the prescribed performance guarantee, necessary letter to commence the work shall be issued, and the site of work handed over to you thereafter.

Please note that the time allowed for carrying out the work as entered in the tender is **3** (three) months including monsoon period which shall be reckoned from the 25thday after the date of issue of this Letter.
