NOTICE INVITING e-TENDER

On behalf of the President of India, tenders are invited through e-Tendering by the **SUPERINTENDING ENGINEER-cum-HOD, ELECTRICITY DEPARTMENT, PUDUCHERRY**, from the reputed Manufacturers /Electrical Contractors/ Consortium of Firms for the scope of work "**Design, Supply, laying , testing and commissioning of 3 core, 400 sq.mm 11KV UG cable through HDPE Pipe in Puducherry town in connection with conversion of 22KV OH feeders into 11KV UG cable feeders** " under Smart City Mission Project of Government of Puducherry implemented by Puducherry Smart City Development Ltd (PSCDL) through the Electricity Department, Puducherry(PED).

To participate in the tender through the e-tendering mode, parties have to obtain Digital Signature certificates (DSC) through which they can register in the website www.pudutenders.gov.in and upload their offer. For further details and assistance in e-bidding, the Tenderers may contact the "e-Procurement Cell, 3rd Floor, Chief Secretariat, Puducherry. The Help Desk number is (0413 - 2220225). For their own benefit, it is suggested that the Tenderers may contact the above telephone number for training.

The estimated cost of the tender is Rs. 9,60,29,000/-

The Bidder who had downloaded the Tender Schedule from the website shall submit the Tender Schedule on-line before the scheduled time of submission. The tender forms will be electronically issued to Bidders only on receipt of Tender fee of **Rs.1,770/- (Rupees one thousand seven hundred and seventy only)**(inclusive of GST) and shall submit the E.M.D for **Rs. 24,00,800/- (Rupees Twenty four lakhs and eight hundred only)** should be paid in the form of Demand Draft / Banker's Cheque drawn in favour of **The Drawing and Disbursing officer, Division-EHV, Electricity Department, Puducherry. Bank Guarantee is also acceptable from any Nationalized Bank for the equivalent amount of EMD.** Demand Draft should not have been drawn before the date of the notification. CASH / CHEQUE / POSTAL ORDERS / TELEGRAPHIC MONEY ORDER WILL NOT BE ACCEPTED.

The Tender shall be in Two Parts namely "**Technical bid**" and "**Financial bid**" with three separate covers marked as detailed below and shall be uploaded in the e-tendering portal separately as detailed below:.

Cover -A: i) EMD & Tender Fee.

ii) Bid Qualifying document along with Type test reports and Affidavits.

Cover -B: Technical requirements, GTP, Schedules, Annexures, drawings

Cover -C: Financial Bid.

COVER – A: The scanned DOCUMENTS of Bid qualifying requirements, Type test reports and affidavits as per Section-II of the tender document, should be uploaded in the website and the copy of the same should be submitted in a sealed envelope superscribed as “Bid qualifying documents”. The Bid security & Tender Fee should be in a separate sealed envelope super scribed as **Bid Security for the Scope of work “Design, Supply, laying , testing and commissioning of 3 core, 400 sq.mm 11KV UG cable through HDPE Pipe in Puducherry town in connection with conversion of 22KV OH feeders into 11KV UG cable feeders ” under Smart City Mission Project of Government of Puducherry implemented by PSCDL through PED .**

The overall envelope called Cover – A should be addressed to the below address well in advance before the date of opening the tender.

COVER –B: The scanned copies of GTP, Schedules, Annexures and other important documents and as specified under this tender specification should be uploaded in the e-portal and the copy of the same should be submitted in a sealed envelope mentioning the description of the item tendered and Specification No. and addressed to the below address well in advance before the date of opening the tender. The scanned copies of other important documents that are mandatory under this tender can be uploaded by scanning the document with less resolution i.e. 100 dpi, as there is size restriction for the OID in the e-portal. However, there is no restriction in file size of the Cover – B documents.

COVER - C: Rate to be quoted on-line only in BOQ as indicated in the e-tenderformat as given in the website. **BOQ should not be modified or replaced by the Bidder and the same should be uploaded after filling the relevant columns, else the bidder is liable to be rejected for this tender. Bidders are allowed to enter the Bidder Name and the Values only.**

Price quoted should be F.O.R site, Puducherry, and Inclusive of all taxes and other charges as admissible. The scope of work shall completely cover the taxes, transport and freight, insurance including Octroi expenses if any and transit insurance, etc.

In the left bottom of the outside envelope the name of the Bidder and his address shall be indicated clearly.

1. The interested bidder can download the bidding document from the website <http://pudutenders.gov.in>.

2. Bidders are advised to download bid submission manual for the help of Bid Submission process from the “Downloads” option as well as from “Bidders Manual Kit” on website <http://pudutenders.gov.in>.
3. To participate in bidding process, bidders have to get ‘Digital Signature Certificate, to participate in online bidding. The bidders have to submit their bids online in electronic format with digital Signature. This certificate will be required for digital signing the bid. Bidders can get above mentioned digital certificate from any approved vendors. The bids proposed without digital signature will not be accepted. No proposal will be accepted in physical form.
4. Bids will be opened online as per time schedule mentioned in table below.
5. All the required information for the bid must be filled and submitted online.
6. The cost of the bid is not refundable.
7. Parties who are interested to participate in the tender are to upload their offer in the website www.pudutenders.gov.in directly. The original copy of the EMD and bid documents shall be sent before the opening of the tender.

9. Bids submitted through post, fax, e-mail, Telegraph or Telex will not be accepted.
10. Bids not accompanied by the requisite bid security of adequate value in a separate sealed cover shall not be entertained.
11. PED reserves the right to reject any or all bids without assigning any reasons thereof.
